#### Ongredients:

- 1 BOX OF RED VELVET CAKE MIX (AND THE INGREDIENTS LISTED ON BOX)
- 8 OZ CREAM CHEESE SOFTENED 16 OZ WHITE CHOCOLATE CHIPS 2 OZ DARK OR SEMISWEET CHOCO-LATE CHIPS

#### Oirections:

- 1. Prepare the 9x13 inch cake according to package instructions. Let it cool completely, then crumble the cake in a large bowl.
- 2. Add softened cream cheese and knead gently with your fingers until the cream cheese is fully incorporated.
- 3. Roll one heaping tablespoon of the mixture into balls and place on a baking sheet lined with parchment paper. Set in the refrigerator to chill.
- 4. Melt white chocolate in a bowl. Use a fork to dip the chilled cake balls into the melted chocolate. Roll the ball in the chocolate to coat evenly, then remove and gently place on the parchment paper. Place them in the refrigerator until chocolate is firm.
- 5. Melt dark chocolate, transfer into a small bag, cut the corner off, and drizzle the melted chocolate over the truffles.

#### Patti Graham, SC FAST



This month we're excited to feature Patti Graham, the state coordinator of South Carolina First Responders Assistance and Support Team (SC FAST). SC FAST, a group through the SC State Fire-fighters' Association, was established in 2012 to provide training and support to our state's first responders – firefighters, paramedics, 911 telecommunicators, and law enforcement – to help them overcome mental health challenges after witnessing traumatic events.

SC FAST was the first statewide team of its kind in the nation. As the state coordinator, Patti works with regional coordinators to set up training sessions across South Carolina. Sessions can be as small as a one-on-one training or can be as large as needed. SC FAST uses a peer support model, which means all training sessions are led by volunteer first responders. Patti has seen firsthand how SC FAST has helped first responders. She said, "We've seen lives changed, marriages saved, lives saved - just by connecting someone with help. Just letting people know they're having a normal reaction can be really helpful for them." ## **CASE RESULT:**

#### Bars That Violate the Law Must Pay for the Harm They Cause

It is against the law for a bar to serve someone beyond the point of intoxication. It is even worse to do so, then allow the drunk person to leave your bar and get out on the road with our families. This is how innocent people's lives are broken and often lost. Bar owners know it, bartenders know it, and people who get drunk at bars know it, too.

Lawmakers also recognize this reality, and that is why they passed safety laws which attempt to prevent not only drunk driving, but overserving as well. Sometimes it's hard for a bar to know someone is drunk. Other times it is very easy. For example, if you serve a 5'9", 140 lb. young man so much liquor and beer in a single afternoon that he walks in completely sober then leaves a few hours later with a 20% blood alcohol level, you have broken the law. It ain't that hard to tell someone is drunk when they're at 2.5 times the legal limit...especially if you're sober, and even more so if you're the one who has been serving them all the drinks.

Yet, that is what happened on the afternoon of January 10, 2016, at a Columbia bar. Less than an hour after leaving, the overserved, grossly-intoxicated driver crossed the centerline and crushed a teenager on the way to work. The teenager lived, and despite his broken bones and surgeries, I am glad to say his spirit remained strong throughout a case that lasted almost three years to the date of the incident. His name is Travis, and on his behalf, that of his family, and my own, I ask that we all do our part to hold drunk drivers and lawbreaking bars accountable to the fullest extent of the law. If we do not, no one else will.
