“Smart and a Dollar Will Get You a Cup of Coffee”

This is one of countless sayings I learned from my dad growing up. It was his way of explaining that you have to work for what you want in life. It came to mind as I was thinking about my dad celebrating 50 years in private dental practice this month. Most people told me I was too young to start a practice at 29. My dad started his at 25. In fact, by the time my dad was 25, he had one child, another on the way, and had already served a tour in Vietnam.

He graduated dental school at 22 and joined the Army because he thought it was the right thing to do.

After completing his time in the military, my dad sought out a construction loan, built an office despite not having any patients, and over the last 50 years has built one of the most successful dental practices in the state. My dad is certainly smart, but he got the dollar and that cup of coffee through hard work.

I can’t repeat all my dad’s sayings. However, I hope this one sticks with you.

Rexy's Recipe

Ingredients

- 6 oz Leftover (or fresh) Peeps
Approximately 20 Peeps
- 3 tbsp Unsalted Butter
- 3 cups Crisped Rice Cereal

Directions

1. Use extra butter and coat an 8x8 inch square pan to ensure treats don't stick.
2. In a large saucepan, combine butter and Peeps. Melt them on low heat while stirring, which should take 8-10 minutes.
3. Remove mixture from heat and stir in cereal, making sure everything gets evenly coated with melted marshmallow.
4. Transfer mixture to greased pan and spread evenly.
5. Let cool for 30 to 45 minutes then cut into even squares.
6. If desired, repeat the process to make additional batches using multiple colors of peeps.

Amtrak Picking Up CSX's Tab for 2018 Train Wreck

Over the last year, we got to know Elida and Leon Mars, a wonderful retired couple from Florida who were on their way home from a family gathering when the Amtrak train they were riding crashed just outside Columbia.

The train was operated by Amtrak. The portion of railroad where the crash occurred was maintained by CSX. The National Transportation Safety Board has still not completed its investigation or issued a report, but everyone acknowledges that CSX is the most culpable party. Nonetheless, Amtrak is the entity defending and paying out claims.

For Elida and Leon, their goal was never money – only safety. They, along with their family and nearly everyone else with any knowledge of this incident, thought it was absurd for CSX to know about a deadly problem on its tracks, yet do nothing to fix it. The settlement we achieved for the Mars family had little to do

with medical bills, but a great deal to do with punitive damages and the value our communities place on safety.

During the time we represented the Mars, we were also retained by other passengers on that ill-fated trip. These people trusted Amtrak and CSX to follow safety guidelines and get them home without incident. They had no clue that CSX would knowingly place them in danger that night. They had no idea that a preventable accident would turn into a life-altering crash. This is why safety standards are so critical; this is why we have safety laws; and this is why safety rules must be followed. CSX knew the consequences of their actions, and they chose them anyway. Why Amtrak is picking up the tab, I do not know, but I am glad someone is being held accountable for the conscious disregard CSX had for the well-being of good people like Elida, Leon, and the other folks on board that night.
