## Justice

At the end of my son's baseball practices, we play a game called Knockout. The rules are simple: if you throw a strike, you remain in the game; if you don't, you are subject to being knocked out by the next player if they throw a strike. The game continues until the last player remains. My 6-year-old daughter attended a recent practice, and we allowed her to play Knockout with the team. Of course, her strike zone is called a bit more liberally than the older players on the team which resulted in her knocking out several players, including my son. It was a cool moment...or so I thought.



Riding home from practice, I noticed my son was in a foul mood, and when I asked why, it became clear he was upset about the game of Knockout his sister won. But this was not jealousy. He had, in a fundamental way (at least in his mind), experienced

an injustice. The playing field was slanted to give an advantage to another competitor. At 9 years old, he knew what injustice felt like.

As early as childhood, we know how important justice is, as evidenced by the timeless schoolyard arguments over who "cheated" to win dodgeball or tag. Justice is a word we all speak about with reverence, but we never truly know its importance until we experience its counterpart.

Civil litigation often seems like David vs. Goliath, where the odds are stacked against you in the form of costs, time, anxiety, insecurity, and vulnerability. It is our job as counsel for those hurt by the reckless acts of another to pursue justice despite those obstacles. We empower our clients to stand firm in the face of the pressure that litigation inevitably brings to their lives. Partial justice is injustice. The strike zone may seem bigger and more forgiving in the face of a large corporation's endless resources and team of high-powered advocates. But, at the end of the day, it is still our job to throw strikes. Our clients deserve justice, even if we must fight an uphill battle to get it for them.

## The Practice of Law

### Could v. Should

We could ask another question, take another deposition, add another expert, and file another motion. But should we? Anytime I catch myself saying "I could..." it begs the better question of whether I should.

As lawyers, we're given wide latitude when it comes to just about everything other than trial evidence, and even there, it's not too strict. The law prohibits frivolous filings, but anyone who has been practicing more than one week has seen a frivolous allegation or defense come across their desk. It's incredibly frustrating, especially when we take a step back and remember our goal is to ascertain truth and justice. Results should be based on law and evidence, not arguments and positions that blur lines, confuse jurors, and inject faux complexity. If you want to know which side should win, it's usually the one with the simplest argument

and strongest facts. So why do so many lawyers take so many outlandish positions? Because they can; because their clients, bosses, or insurance carriers expect them to do anything they can to win. *But should they?*

I am neither an ethics scholar nor moral judge. Everyone ought to be empowered to make their own decisions so long as they are willing to live with the consequences. Sometimes the consequence may be winning a case you should lose. Other times, the consequence may be a big win for the other side because a jury saw through the disingenuous nature of your position. At the end of the day, all of us must distinguish *could* v. *should* and make decisions aligned with our own values, interests, and ethics. The most powerful aspect of our license is that it gives us a choice.
