Kelsey Sawyer Carter, Camp Cole Kelsey Sawyer Carter is the co-founder and executive director of Camp Cole, a state-of-the-art facility coming to the Midlands that will allow children and adults facing serious illnesses and mental and physical challenges to enjoy one of childhood's greatest pleasures - camp. Camp Cole was inspired by Kelsey's younger brother, Cole, who lost his battle to Rhabdomyosarcoma, a rare form of cancer, at the young age of 11.

While other programs enable children with medical challenges to attend camp, the facilities are typically created with able-bodied children in mind. At Camp Cole, everything will be designed to cater to the medical needs of the camp's attendees. The impressive campus will include an onsite medical facility, cabins to accommodate nearly 200 overnight guests, a dining hall, a gymnasium, an amphitheater, an Art Shack, a pool, and more, to provide fun options for attendees - no matter what health challenges they face. According to Kelsey, they wanted to create a space that would provide opportunities for able-bodied people and those facing health and physical challenges to join hands and go through experiences together.

Case Results

Paying the Price

Losing cases is the price lawyers sometimes pay in seeking justice. When you are willing to take on and try cases, you know that in so doing, you are taking on the risk of defeat in battle. That is an acceptable risk in the larger war for community safety and the sanctity of a human being's life and health. I never want anyone to feel bad for us after a defeat. The price we pay is small compared to what is taken from a client.

On Halloween, a jury returned a verdict against one of our clients. The jurors may have been confused by legal terms – which means I should have done a better job explaining them. Or they may have thought we needed more medical evidence or that people should not receive money for pain and suffering, despite the law's instruction. You never know what 12 strangers will decide when it comes to another's fate, but I do know my wonderful client deserved something more than her day in court.

She paid a high price for another person's negligence in terms of her injuries. She then paid again in the form of sitting through trial, having her life dissected, and having jurors conclude her injuries were not caused by a crash – despite the actual evidence.

Even though this wonderful woman owes no legal fees (it was a contingency fee), nor costs, and while I know we did everything in our power to achieve a fair, full verdict, when I woke up on November 1, I could not help but think of how our client felt when she woke up. She paid the real price. It will not be in vain, however. For the wisdom and motivation I gained from this result will lead to many victories on behalf of many others. Though this client may never meet those people, they will have her to thank, in part, when the verdict in their own cases is read and echoes loudly back to her.
