

We opened our Myrtle Beach office in March of 2020.




Attorney Kenny Berger opened the Law Office of Kenneth E. Berger on Forest Drive on January 3, 2011.

Trial Readiness

Ironically, the best way to get a case settled is to prepare it for trial. But what does preparing a case for trial look like? What is trial readiness?

It's not posturing or insulting your adversary. It's not complaining about insurance companies or your client. It's work, and it starts from the first time you speak with a client.

Trial readiness is a product of trial preparation, which itself emanates from one's mindset. Put simply: is the case being prepared for settlement, or is it being prepared for trial? When settlement becomes the primary objective, corners are often cut, lawyers think more about their third than the client's well-being, and trial becomes a dreaded last resort. Conversely, when trial is Option A, cases are prepared with an eye toward jury persuasion, admissible evidence, and powerful witness testimony. The focus is on the client's story rather than the lawyer's lifestyle.

Thus, from the first meeting through closing argument, preparing a case for trial means absolute dedication to another human being's interests. It means listening, not to figure out what you'll say next, but to empathize and put yourself in the shoes of the speaker. It means working, not simply to make a living, but to give another person back their life. It means fighting, not for the sake of defeating an adversary, but for the cause of civil justice and the values that form its core.

Trial readiness is the outcome of one's listening, work, and fight. It's often tedious and lonely. It comes at the expense of other interests. It can be exhausting. However, the fulfillment that comes from a job well done is worth the sacrifice for those who make it.

This principle is true not only for lawyers and trials, but for all people seeking any form of victory or success.
