#### **Ongredients:**

- **2 CANS CINNAMON ROLLS**

- 8. Remove from the oven and drizzle with the cinnamon roll icing. Serve with warm maple syrup.

## **CASE RESULT:**

#### 18 Wheelers, Drunk Drivers, & Our Roadways

This section of our newsletter is usually dedicated to a specific case result. Over the last two months, however, we've had a number of cases that involve either tractor-trailers or intoxicated drivers. So instead of highlighting one case, I wanted to call attention to what can be done to combat the dangers posed by both trucking companies and drunk driving.

First, it's time lawmakers revisit the qualifications necessary to get behind the wheel of a tractor-trailer. As it stands, getting a commercial driver's license and being given the keys to a 75,000 lb. vehicle is much easier than obtaining a job with far less public safety implications. Trucking companies often hide behind minimal standards to get more and more drivers, and more and more trucks out on the road. What does that lead to? More collisions and more otherwise preventable harm to innocent people.

Second, our courts should take a tougher stand when it comes to the legal responsibilities of the companies that "broker" deals between shippers and trucking companies. Often times, the broker is getting the best end of the deal, while also turning a blind eye to the trucking company's safety record. Until these transportation brokers are held accountable for giving jobs to the most dangerous trucking outfits – often because they are the smallest and cheapest – it will be business as usual, and the threat will continue.

Third, we can all call on our legislators and judges to finally get tough on drunk driving. I knew DUI was a problem, but was surprised to learn just how much of an epidemic it remains despite MADD, Uber, and increased public awareness. The numbers do not lie. For instance, over the last 10 years, more than 100,000 Americans have been killed by intoxicated drivers (more than 10,000 of them were children). In economic terms, drunk driving costs the United States more than \$44 billion annually. It is the equivalent of a war on our roadways – and we are losing. As a community, we need to go on the offensive against intoxicated drivers and the establishments that profit by overserving them. That starts with ensuring that laws are not only made, but enforced. So long as the vast majority of drunk drivers and bars get away with a slap on the wrist or a stern warning "not to do it again," it will happen again and again and again. It's time we stand together and say in a single voice, "Enough. It stops now, and it stops here."
