Approximately 60 to 65 percent of South Carolina's firefighters are volunteers, but there is a severe shortage in our state and across the country. ## Case Results

### Seven Million In Seven Days

Between May 16 and 22, we were able to resolve a series of very important cases for some extraordinarily deserving families. These were not overnight results, but rather the product of getting to know, care for, and champion the cause of wonderful people who were robbed of a family member.

One family lost a wife and mother. A different family lost a husband and daddy. And a third family lost a child, who only moments earlier was talking to his momma and looking forward to spending time with grandbabies. I am close with each of these families, though two of them were strangers to me only a couple years ago. Whenever you're dealing with the loss of life – when someone is literally taken away – you know money is never going to breathe life back into their lungs. That is not the purpose of the law, however. The laws of our com-

munity exist to protect further harm and to impose accountability on wrongdoers; the law recognizes the inherent value in getting to hug a parent, hold a child, and grow old with a soulmate.

I take no joy in tragedy. It makes me sad. When survivors hurt, I hurt with them. I take pride, however, in giving these families a voice - in upholding their rights and guiding them through a justice system that exists to give meaning to what they still have: love.

While these families and their love for each other were arguably the most important factor in the outcomes, the tremendous work of great co-counsel, including Randy Hood, Shawn Deery, and Nick Cotten, were also critical. These are fine lawyers who I enjoyed battling alongside in the good fight.
